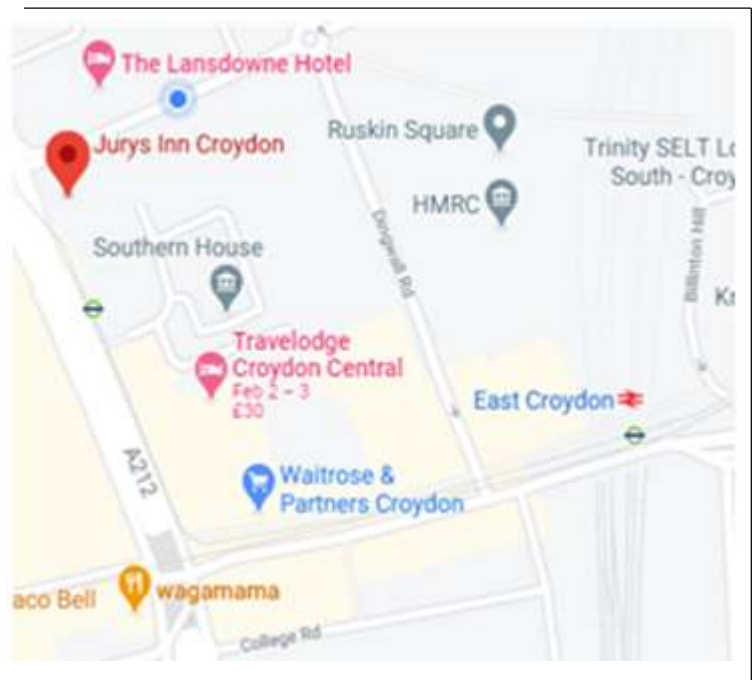

### Travelling to court

**Travelling by train:** The nearest train stations are East Croydon and West Croydon. The nearest tram stations are Wellesley Road and East Croydon.

**Travelling by bus:** The nearest bus stops are Fairfield Halls, West Croydon Station, East Croydon Station and Wellesley Road Whitgift Centre.

**Parking:** There are no car parking spaces available at the court. The nearest car parking is available at Whitgift Centre NCP.



## **Court rooms**

There are two Crown court rooms at Jurys Inn. Court 11 will hear applications and appeals and Court 12 will hear Jury trials.

- Court 11, First Floor
- Court 12, Second Floor

## **Public / press gallery for Court 12**

Due to social distancing measures there is no public / press seating in Court 12. Proceedings are live streamed to a room located on the same floor.

## **Advocates Robing**

The advocates robing room is located on the First floor. Keys can be obtained from court staff on the first floor and must be returned each day. There is a telephone in this room which should only be used for internal calls.

## **CPS**

The CPS office is located on the Second floor. Keys can be obtained from court staff on the Second floor and must be returned each day. There is a telephone in this room which should only be used for internal calls.



## **Citizens Advice / Witness Rooms**

There are two witness waiting rooms, located on the First floor. Keys can be obtained from court staff and must be returned each day. There is a telephone in each of these rooms which should only be used for internal calls.

## **Consultation rooms**

There are four consultation rooms available for counsel to use. These are available on a first come first served basis.

- Consultation Rooms 1 and 2 are located on the First Floor
- Consultation Rooms 2 and 3 are located on the Second Floor

## **Professional court user scheme**

The professional court user scheme will not be operational at this court.

It should be noted that there are security arch / search areas located on both the first and second floor. Therefore you will need to pass through this search area when transiting between floors.

## General information

Please note that due to the time it takes for jurors to transit at social distance into court, points of law should be highlighted in advance.

Face coverings must be worn when in the public areas of the building e.g. corridors, public waiting areas, public / press gallery, consultation rooms.

All persons, including jurors, are strongly encouraged to wear masks/face coverings in the courtroom except for the judge, the advocate who is speaking and the witness giving evidence.

Only bail cases will be heard at Jurys Inn unless the defendant appears by video link, there are no custody arrangements in the building. Sentencing where custody is an option will be heard at Croydon Crown Court. There will be a team of court security officers at Jurys Inn at all times.
